Aikido of Salt Lake is pleased to invite you to the 3<sup>rd</sup> International Seminar with Roberto Nobuhiko Maruyama Sensei (7<sup>th</sup> dan) of São Paulo, Brazil, Nov. 17-19, 2017. He will be accompanied by two 4<sup>th</sup> dan, two 3<sup>rd</sup> dan, and two 2<sup>nd</sup> dan students from Brazil. The Friday session will be held at Aikido of Salt Lake in downtown Salt Lake City. Saturday and Sunday sessions will be at the Unified Police/Salt Lake County Sheriff's Office Training Center.

Roberto Maruyama Sensei is the founder and leader of the Maruyama Institute of Aikido, which has 25 dojos training more than 800 aikidoka across Brazil. In 2015, the Maruyama Institute was officially recognized by Aikikai International (Hombu) for the promotion and dissemination of Aikido in Brazil. Maruyama Sensei has close ties to both Hombu Dojo and Masakazu Kitahira Shihan (8<sup>th</sup> dan). He served in the São Paulo Police Department from 1997 to 2015, and was Chief Instructor of the São Paulo Police Special Operations Group for 10 years, where he trained more than 100 police officers in self defense.
